Part B. CV SUMMARY (max. 3500 characters, including spaces)

Francisco González has been Professor of Finance at the University of Oviedo since 2006. He was President of the Spanish Finance Association between January 2014 and July 2016, Executive Editor of the Spanish Review of Financial Economics (SRFE), Associate Editor of *Cuadernos de Economía y Dirección de la Empresa* (CEDE), and Associate Editor of the Universia Business Review (UBA). Francisco González's main interests are banking and corporate finance. His research analyzes the relevance of financial regulation and institutions for banking development and stability, and the links between banking systems and the investment and capital structure of industrial firms. Recent papers have analyzed the effects of banking crises on economic growth and market discipline and the relevance of bank size and market structure for future financial stability.
