From September 2017, I have participated as an expert for the European Commission to advice in Innovation Policy Funds, ESIR group has advised DG Innovation Policy for the next H2030 project funds.

I teach Organizational Behaviour, Management and Introduction to Business at the degree level. I also collaborate in many PhD. Programs at Universidad Carlos III, Universidad Pablo Olavide, Universitat Autònoma de Barcelona. I participate in several Executive programs as Gestión de Organizaciones Sanitarias and Master de Consultoría de Empresas. I have 5 quinquenios and I am involved in the use of a new teaching methodology "Flipped classroom" applied to the graduate and bachelor levels.



The main research interest relies on the analysis of innovation decisions, innovation types and their effects on firm performance.
