 teleological criteria.
 - That was clearly the case in the legal opinion that I produced at the instances of the Jurisconsult of the CoE, on the interpretation of Art. 36.b of the CoE Statute concerning the election of the Secretary General and setting up the obligation, according to the principle of loyal cooperation among institutions of a IGO, to reach to an agreement between the Parliamentary Assembly and the Committee of Ministers for the election of the Organization's Secretary General.
- Capability to deduce, according to potentially applicable provisions, solutions grounded on the law and to propose new
 developments when required.
 - This was the case with the entry into force of the Treaty of Lisbon and the transformation of EU Commission delegations into EU permanent representations and the transformation of EU Commission representatives into ambassadors within the CoE organization, apart from other legal aspects directly concerning CoE activities, as it was the case within the working group negotiating the draft agreement for the accession of the EU to the ECHR.
- Ability to conclude after a research on the main points to be dealt with, and to make a clear exposition of the main results produced.
 - This was the case of the potential reservation intended to be introduced by the Russian Federation concerning Protocol 14 to the ECHR in order to avoid certain of its provisions, the final conclusion of a protocol 14bis having been achieved which, nonetheless, did not finally enter into force, once the task developed in order to convince the Russian Federation was fruitful.
