Part B. CV SUMMARY (max. 5000 characters, including spaces)

Head of ARMAQoL-GIUV2017-359 (Advanced Research Methods Applied to Quality of Life Promotion), an interdisciplinary group (https://www.uv.es/uvweb/research-service/en/research-groups/grup-1285949714098.html?p2=GIUV2017-359). 4 six-year research terms recognized (the last one 2011-2016), 5795 citations so far, h-index=36, i10-index=94.

Our topics of research are mainly focused in contributing from methodology to several areas of quality-of-life promotion, not only older adults and successful aging. Although many efforts are in the development and testing of predictive models focused on older adults' population, based on knowledge on loneliness, depression, personality traits, social and physical activity, quality of life dimensions, ... there are also further contributions, mostly research on the area of palliative care and end of life. In this area, I have worked in the improvement, validation and measurement protocols for patients and their health-care professionals. When attending patients, focusing on constructs such as self-care, dignity, spirituality, coping with death, or demoralization, ... When working with healthcare professionals research has also been extended to many other professionals attending high emotional demands. This is the case of policemen, staff working with people with mental disabilities, or



professionals in childcare with special needs. In these topics, research efforts are methodology focused, developing and validating new measures, studying properties as gender or cultural invariance. Also developing short measures to improve the applications in applied challenging contexts. Another topic of research in which I am involved is the promotion of entrepreneurial attitudes in youth. For that, our own research protocols have been developed (EASS, Oliver & Galiana, 2015). Currently we integrate this measures in theoretical well-known models useful to monitor outcomes of interventions. These interventions are in line with quality-of-life promotion, as they are expected not only increase entrepreneurial intention, but prosocial behavior, self-efficacy, academic achievement, etc.

Similarly, the transference with research in developing measurements and interventions regarding sexism as a construct to prevent gender violence has been fruitful. The ICT have been successfully used developing patented applications as Liad@s with an excellent assessment in educative institutions and especially working with vulnerable youth.

An important part of my activity takes place in the PhD program of Promotion of Autonomy and Socio-Sanitary Attention to Dependency with the role of coordinator. Most of my recent research profile is done in collaboration with our former PhD students and/or collaborators that now become recognized researchers. This is the case of Laura Galiana, Patricia Sancho, David Rudilla, Gabriel Vidal-Blanco, Noemí Sansó,...Or some others currently PhD candidates, as Irene Fernández, Sara Martínez, ...My PhD supervised so far are 20, 17 in the last 10 years period.

Research visits and collaborations into the time period with Barry Schneider (*University of Ottawa, Canada in 2012 and later in 2018 Boston College, MA, USA*); Julian Montoro 2015 (UNCC at Charlotte, NC, USA), Shane Sinclair (Calgary, CA), Eve Ekman (San Francisco, USA), David Kissane (Monash University, AU), Michael Silbermann (Middle East Cancer Consortium, IL), Fernanda Arena in Brasil (CNPq) and Argentina (Prof. Gustavo de Simone, Pallium). In 2018 a funded research stay at RCC Harvard with IECO-UV (Boston, USA) and 2019 in ESAN Business School FabLab+Incubator (Lima, Peru).

Intervention protocols as GES and KIBO at the end of life have been not just published but successfully transferred from 2019 as therapeutic tool in applied settings as Psychosocial Attention Teams (EAPS) from Madrid & Castilla-La Mancha or included into the training program for professionals of SERMAS (Servicio Madrileño de Salud) for 3 years. David Rudilla (former PhD in 2014) currently responsible as Patients and Quality Outcomes Research Manager, at Home Healthcare Europe Cluster of Vital Air (Air Liquide Company) is the main driver for this transference.

Research transference profile includes being member as expert of relevant citizens' committees. Developing initial draft of the Law for Dignity and Quality at the End of Life since 2018, and currently member of Consulting Committee for the Implementation of Organic Law 3/2021, as expert designated by the Valencian Government. Also, local conferences and talks about self-care & successful aging along the Valencian Community (Requena 2017, Quart de Poblet 2016) and additionally, impact actions dealing to the Award in Research Transference to the Citizens 2016 given by *Federation of Valencian Neighborhood Associations*.
