He has been a university lecturer in the Department of the Theory of Education and Social Pedagogy (UNED9 since 2009. Likewise, he has been a permanent lecturer at the same university since 2018, being accredited in 2014. As a researcher, he started out with an FPI scholarship in the Department of Developmental Psychology and Education at UCM between 2005 and 2009, undertaking his doctoral thesis. He is a PI in the Socio-educational Intervention UNED research group. From 2019 and up until the present day he has been a member of the Measurement and Evaluation of Educational Systems group at UCM and the OCT-TS Leisure, Culture and Tourism for Social Transformation research team (Ref: IT457-22) at the University of Deusto. He was a member of a research group into social inclusion and human rights (TABA I.R.) at UNED for 4 years (REF: G482). He was a member of the Interdisciplinary Research Group into Professional Teaching Competencies (REF: 949562) ran by UCM and the 1





community of Madrid for 7 years. He has participated in 14 competitive research projects, with 4 being regional, 3 national, 3 European and 4 R+D+i (4). He has participated as a researcher on five contracts administered by social entities and universities with view to transferring knowledge to the social sector. Likewise, he has participated in various R+D+I activities. He was PI of the project named "Evaluation of the Transition to Adult Life in Young People who have gone through the Care System". Between 2009 and the present day, he has also formed part of the Ociogune Excellence Network (RED2018-102625-T). Since 2012, he has been a member of the Network for Research and Training in Young People and Inclusion. Between 2018 and the present day, he has been a member of the Study Network into Youth and Society 2.0 (REJS) and the Lachesis Network of the SM Foundation.

He has more than 150 publications. More than ten books and more than fifty articles published in journals such as Educación XX1, Psicodidáctica, Revista Española de Documentación Científica, Revista de Educación, Social Work Education, Revista Española de Pedagogía, European Journal of Social Work, Frontiers in Psychology, Revista Complutense de Educación, Estudios sobre Educación, Pedagogía Social Revista Interuniversitaria and the European Journal of Teacher Education, amongst ohers. He has participated in more than 70 national and internaitonal seminars, courses and scientific conferences.

He has completed research placements abroad at London University, the Thomas Coram Research Unit of the IOE as a visiting lecturer under the supervision of Doctor Claire Cameron. He has also stayed at the Fraternal Institute of Guimaraes (Portugal) as part of the European RISEWISE project entitled Women with Disabilities in Social Engagement. Placements at renowned research centres in Spain include at the Department of the Theory and History of Education at UCM and the Department of Social Psychology and Quantitative Psychology at Barcelona University.
